


A Balancing Act

Michigan's new Employee Sick Time Act has created a great discussion about balancing the need for employees to take time off and the need for employers to have staff on site to accomplish the work. The Employee Sick Time Act provides paid time off for all workers in Michigan and gives guidance to how and when employees can use that time.

Our work at Harbor House adds a dimension to the conversation, as caregivers need to work "in person" and our homes never close. Whether it's a holiday, a blizzard, or even a pandemic, we need our staff on site to care for the men and women who live here.

So, how do you balance the need for 24/7 care and the need for staff to have time off—sometimes unplanned and unpredictable? We must pay overtime or shift premiums to cover for call-offs. This, in turn, increases the cost of care.
